Description and Purpose:

ON Semiconductor wishes to promptly inform our customer of our intent discontinue production for the below devices due to the following fab process discontinuation in our Fab 2 Belgium wafer fabrication location: C24C, B20B, B30B.

The fab processes will be discontinued in the next three years.

Due to the necessity of a possible redesign for some of the ASICs, we are providing an extended EOL notification period.

Therefore, the discontinuation dates are as follows:

End of life buy orders must be placed on or before 01-Jun-2017

End of life buy orders must be shipped on or before 30-Dec-2017

ON Semiconductor has provided a list of replacement devices, where available, to aid in this process.

PLEASE NOTE: ON Semiconductor may implement minimum order quantities or dollar amounts based on inventories available. Also, Devices on this Product Discontinuance become NCNR (Non-Cancelable, Non-Returnable).
