Change Description: A new product version ATA5781N-WNQW is introduced supporting pureRXMode operation. Customers using pureRXMode need to order ATA5781N-WNQW. The pureRXMode is a special mode which needs to be activated via EEPROM setting. Standard RX modes (buffered and transparent) are not impacted.  Figure 2-4. In general the pureRXMode works. Only in the unusual case, when parallel signals and special timing occurs at the same time, the device stucks in pureRXMode. A toggling at PIN18 (PC4) which controls the pureRXMode sets back the device to the target operating mode.
